Q&A with Mike Staten

Teaching Assistants

Kathleen: Restrictions on hiring external GTA for programs without grade programs.

Specifically, an issue for the three Norton School academic programs without grad programs – RCSC, FITS, and PFFP (to a lesser extent due to small course size).

Mike's response was that there is no CALES restriction on hiring GTAs outside of the College.

Jean McLain made a comment: That one unit report there is no transparency about how TAs are being assigned. She is working on this.

Katie Zeiders: Ask for an explanation about how TA funds are allocated?

Mike Staten: responded that the changes:

- Decoupled from GenEd and Service Courses
- Allocated based on SCHs delivered by unit
- Unit heads are to distribute this in an equitable and transparent way
- ERE is included in the budget

The task force did not recommend allocating this in a standardized way across the College but leave it to the unit heads.

Faculty Workload

Ashlee Linares-Gaffer provided a summary of the overall issues.

Mike Staten responded that solving this needs to start with improved faculty awareness:

- 1. A workload policy memo went out to all faculty in the College. FC reps should resend this faculty.
- 2. Send an annual report on course releases.

Setting up a process for equitable treatment that does not solely rely on faculty.

- 1. New course prep there is a course proposal and a faculty member who authored the proposal.
- 2. Course proposal will not work for all situations because some course development is not based on

- Some questions were asked about the status of the UA Budget process.
- A brief update on the CALES Budget Working Group was provided.

Recommendation: The Faculty Council will propose a process for faculty workload equity and review.
