Status Report on the Federal Excess Property Program (FEPP)

Division of Agriculture, Life and Veterinary Sciences, and Cooperative Extension (ALVSCE)

August 31, 2018

The Division of ALVSCE is eligible to participate in the FEPP Program because The University of Arizona is a land grant institution. This program allows us to acquire federal excess property through USDA with the only cost being transportation to the department/unit. The title remains with USDA and we are able to use the property until no longer needed at which time there are specific disposal procedures through USDA and GSA. Other program requirements include accurate and detailed records of FEPP equipment as well as physical verification of equipment every two years.

From July 2015 until present, the focus of our program has been on disposal of items that were stockpiled over decades. During this three years, we have processed over 220 equipment items for disposal through GSA Sales and inter-agency transfers with a remittance of ~\$233,500 to the federal government. In addition, we disposed of 245.050 pounds of other disposal items through a recycling/scrap vendor remitting \$10,200 to the federal government.

Jeffrey Ratje placed a voluntary freeze on new acquisitions to allow time for disposal of stockpiled items and organize and update the FEPP equipment and program records. This was part of his pledge to the USDA to improve our operation, and necessary to forestall punitive actions by the agency due to the years of mismanagement. On behalf of Jeffrey and the FEPP Team (Mary Kate Barrett and myself), we express our thanks for your patience during the lengthy clean up and disposal process, and are happy to report that we have regained the trust of the USDA FEPP-coordinator.

As of Fiscal Year 2018-19, we will now review requests for new equipment acquisitions. Equipment items such as tractors, trucks, trailers, etc. are more difficult to obtain than in the past, but our FEPP Team will work directly with the designated Unit Coordinator to assist and answer questions. All requests must go through the assigned unit coordinator with approval by the Director or Department Head. Established processes must be followed. Attached is a list of the current assigned coordinators. If your department/unit is interested in obtaining federal surplus property, please complete the attached form and return it to Madge Mock for formal acknowledgement.

A separate notification will be sent to directors, department heads, and FEPP Coordinators with information and instructions on acquisition requests.
