## **Meeting Minutes**

 Faculty Senate update: Duarte Diaz, Extension. Two extension programs received approval for waiver of the spending authority. Previously the Senate Chair was pushing for freedom of speech, but now it is postponed indefinitely. The Faculty Recalibration Committee discussed changes in the University spending. The report shared last time indicates an increase in pay for administrators, and this does not include additional expenses for paying several administrators upon their separation from the university. Change needed in review process of GenEd courses. Now takes 15-18 months to approve a GenEd course.

2. Dean's Update: Dean Burgess. ALVSCE submitted Anaplan budget to the University on December 20<sup>th</sup> for all 3 major units of ALVSCE – no news yet. In the proposed budget by ALVSCE there are no cuts and pay raises are planned. Spending authority last time did not include a Food Products and Food Safety Lab with \$0.5 M budget that will reopen in March. Katleen asked if the proposed budget can be made public on ALVSCE Compass and the Dean said that he will explore this.

Deans and Provost meet on Mondays every 2 weeks. A recent paper in Arizona Daily Star indicated that there is still \$65 M structural deficit after the cuts. The total budget for the university is \$3.6 billion, \$65 M is a relatively small amount. President will receive a bonus if he can eliminate it. Richard Cate, former Vice President for Finance and Administration at the University of Vermont, will serve as a Special Advisor to the President to help achieving this goal. The current budget model runs the University as enterprise, but this overlooks mission of the University. As a result of the latest election, republicans have more control over the State Senate and the House. They already contacted Dean Burgess to ask why extension is not delivering its mission to stakeholders. For the coming Fall expect fewer students because 1) University will no longer pay them to come and 2) because of the demographic cliff (though our part of the country is less impacted). Last Fall enrollment was higher than expected, a record of 9,500 students, 2,500 of them accepted after May making it difficult to plan. The Math department is particularly impacted by lager enrollment now. CALES is a transfer college, so may see an impact in two years. New medical undergraduate degree is part of the increase.

University now prioritizes protecting teaching, but the Higher Education Research and Development (HERD) number can be impacted as a result. Forty faculty and 43 staff members left. So far, the College has been less impacted by this because the majority of faculty leaving were due to retirements and retiring faculty tend to wind down their research. However, Dean's Research Advisory Council (DRAC) report indicated work (particularly administrative) transfer from staff to faculty, which is not efficient, as it takes more time to perform tasks if they are not routinely done.
